The **Sri Lanka Export Development Board (EDB)** invites eligible Consultants/Experts to undertake and implement the activities under the Multi-National Corporation Outreach Programme for Electrical & Electronics Manufacturing Industry. The programme envisaged to establish 3-5 Global Electronics & Electrical Manufacturing Multinational Companies (MNCs) in Sri Lanka by 2022. Interested consultants must provide information indicating that they are qualified to perform the services (Brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Selected Consultants/Experts must have proven success stories of attracting Foreign Direct Investments (FDI) in a given period of time.

The Consultant/Expert will be selected in accordance with the procedures set out in the Guidelines for Selection and Employment of Consultants, published by National Procurement Agency.

#### **Services Required**

- a) Set a Road Map to bring down and establish 3-5 global EEM Multinational Companies (MNCs) in Sri Lanka within 3 years (2019-2022) to increase Foreign Direct Investments (FDIs) and direct/indirect employment opportunities
- b) Identify strategic and specific opportunities and Competitive Advantages where Sri Lankan EEM companies can plug into Global Supply Chains
- c) Bring down and establish 3-5 EEM Multinational Companies (MNCs) to Sri Lanka by year 2022 (first MNC to be established by 2020) and assist Board of Investment of Sri Lanka (BOI) to successfully sign the agreements with interested MNCs.
- d) Consultant should preferably have liaising officers in countries where EEM Multinational Companies (MNCs) are located, so that investment promotion can be done effectively by maintaining a rapport with targeted MNCs to promote Sri Lanka as an Electronics and Electrical Design, Development & Manufacturing base in the world.
- e) The consultant should work closely with Ministry of Development Strategies and International Trade, Board of investment of Sri Lanka (BOI), Sri Lanka Export Development Board (EDB), and Sri Lanka Electronic Manufacturers and Exporters Association (SLEMEA). Progress to be reported on monthly basis.
