


MARKET REPORT – TANZANIA

1 BASIC FACTS

1.1 Location

Tanzania is located at the East Africa on the Indian Ocean and it is bordered by Kenya and Uganda to the north; Rwanda, Burundi and the Democratic Republic of the Congo to the West; Zambia, Malawi and Mozambique to the South,

1.2 Surface area

The country covers an area of 947,300 square kilometers out of which 61 500 sq.km are covered by water and 885 800 land.

1.8 Language

Kiswahili or Swahili (official), Kiunguja (name for Swahili in Zanzibar), English (official, primary language of commerce, administration, and higher education), Arabic (widely spoken in Zanzibar).

1.9 Climate

Tanzania's weather varies from humid and hot in low lying areas, such as Dar es Salaam, to hot during the day and cool at night in Arusha. There are no discernible seasons, such as winter and summer -- only the dry and wet seasons. Tanzania has two rainy seasons: The short rains from late-October to late-December, a.k.a. the Mango Rains, and the long rains from March to May

2. ECONOMY

The economy is heavily dependent on agriculture, which accounts for half Of GDP, provides 85% of exports, and employs 80% of the work force. Topography and climatic conditions, however, limit cultivated crops to only 4% of the land area. Industry is mainly limited to processing agricultural products and light consumer goods. Recent banking reforms have helped increase private sector growth and investment. Due to continued donor support and solid macroeconomic policies, there notifiable improvement in the Economy of Tanzania.

3.TRADE AGREEMENTS/MEMBERSHIP TO ECONOMIC 6 BLOCS

Tanzania is a signatory to a number of bilateral treaties. It is a signatory to the following regional and international treaties and organisations, among others:

- The South African Development Community (SADC) which includes countries in the southern African region.
- The East African Community, bringing together three countries in the East African Region – Kenya; Tanzania and Uganda
- The African Caribbean and Pacific Group of States (ACP) under the fourth ACP-EEC Conversion (Lome IV) of 1989, signed in 1990 and the Partnership Agreement signed in Cotonou, Benin on 23 June 2000
- The Charter on a Regime of Multinational Industrial Enterprises (MIEs)in the preferential Trade Area for Eastern and Southern African States
- The Intellectual Property Organisation (WIPO)

3.1 Trade routes

Dar es Salaam is a hub for fly in visitors who arrive into the country through the Dar es Salaam International Airport. Apart from air travel, Dar es Salaam can also be reached by sea and is one of the busiest seaports in the Eastern coast of Africa.

3.2 Business Etiquette and travel guide

Appointments should be made in advance and normal courtesies should be shown when visiting business people. Punctuality is important. Suits and ties or safari suits are worn by men, suits and dresses by women. Men shake hands on meeting and on taking leave. Almost all executives speak English. There is no limitation to the importation of foreign currency. Foreign currency can be changed into Tanzanian currency at any branch of the National Bank of Commerce. Tanzanian currency cannot be imported or exported.

Visitors are advised to take anti-malaria tablets before and when on Safari. Personal insurance is advised.

3.3 Specific market access requirements

Normal documentation is required to export to Tanzania (exports permits, import permits, phyto-sanitary certificates)

3.4 Business Opportunities for Sri Lanka

Areas where investment opportunities on Tanzania Mainland abound are in two categories:

- Lead sectors: this is made up infrastructure Rail, Road, Communication, mining, Oil exploration and Export Processing Zones
- Priority sectors: which include Agriculture and Agro-processing, Livestock, Aviation, Banking, Real Human Resources Development, Estate, Manufacturing fishing, Radio and Industries, Television Broadcasting, Land Transport, Marine Transport and Tourism & Travel.

3.5 Other industries with opportunities:

- Manufacturing of pottery, china and earthenware
- Manufacturing of food, beverages and cigarettes
- Manufacturing of glassware

- Manufacturing of construction materials such as cement, concentrate articles, gypsum and plaster products.
- Manufacturing of electrical goods such as switch gears, electric cables, cookers and dry cell and automobile batteries

4.TRADING ACROSS BORDERS

According to data collected by *Doing Business*, exporting a standard container of goods requires 6 documents, takes 18 days and costs \$1255. Importing the same container of goods requires 6 documents, takes 24 days and costs \$1430. Globally, Tanzania stands at 92 in the ranking of 183 economies on the ease of trading across borders. The rankings for comparator economies and the regional average ranking provide other useful information for assessing how easy it is for a business in Tanzania to export and import goods
