Hong Kong is a country in Eastern Asia that covers an area of 1,108 square kilometers and the 184th largest country in the world. Hong Kong is bordered by the South China Sea and China. Hong Kong has subtropical monsoon, cool and humid in winter, hot and rainy from spring through summer, warm and sunny in fall. The country possess outstanding deep water harbor, feldspar as natural resources.

Economy

Mainland China has long been Hong Kong's largest trading partner, accounting for about half of Hong Kong's total trade by value. Hong Kong's natural resources are limited, and food and raw materials must be imported. During the past decade, as Hong Kong's manufacturing industry moved to the mainland, its service industry has grown rapidly. In 2017, Chief Executive Carrie Lam announced plans to increase government spending on research and development, education, and technological innovation with the aim of spurring continued economic growth through greater sector diversification.

2. Trade between Sri Lanka & Hong Kong


Hong Kong is the 17th export destination for Sri Lanka. Total export value from Sri Lanka to Hong Kong was US \$ 183.6 million in 2017 and total imports from Hong Kong to Sri Lanka for the same period were US \$ 439.0 million. Sri Lanka's exports have increased from US \$ 131.8 million to US \$ 183.6 million with reference to the 2013 & 2017.






7. Potential Products to be exported from Sri Lanka

- T-shirts, singlets and other vests of textile materials
- Brassieres of all types of textile materials
- Machines for the reception, conversion and transmission or regeneration of voice
- Activated carbon
- Women's or girls' trousers
- Knotted netting of twine, cordage, ropes or cables
- Women's or girls' briefs and panties of cotton
- Men's or boys' underpants and briefs of cotton
- Wheat or meslin flour
- Made-up articles of textile materials
- Fish fins and other edible fish offal
- Frozen tunas of the genus "Thunnus"
- Gloves, mittens and mitts
- Women's or girls' blouses, shirts of man-made fibres
- Embroidery of man-made fibres on a textile fabric base
- Green tea in immediate packings
