1. Trade between Sri Lanka & Italy

Italy is the 5th export destination for Sri Lanka. Total export value from Sri Lanka to Italy was US\$ 429 Mn in 2016 and total imports from Italy to Sri Lanka for the same period were US\$ 276 Mn. Sri Lanka's exports have decreased from US\$ 510 Mn to US\$ 429 Mn with reference to the 2013 & 2016.

Sri Lanka's main export products to Italy 2016 were Articles of apparel and clothing accessories, Rubber and articles, Tobacco, Fish and crustaceans, Coffee, tea, Edible fruit and nuts. The main import products from Italy Machinery, Knitted or crocheted fabrics, Special woven fabrics, Rubber and articles, Tanning or dyeing extracts, Pharmaceutical products.

GEOGRAPHIC LOCATION

Italy is located in southern Europe and comprises the long, boot-shaped Italian Peninsula, the southern side of Alps, the large plain of the Po Valley and some islands including Sicily and Sardinia. Corsica, although belonging to the Italian geographical region, has been a part of France since 1769. Italy is part of the Eastern Hemisphere.

ECONOMY

The economy of Italy is the 3rd-largest national economy in the eurozone, the 8th-largest by nominal GDP in the world, and the 12th-largest by GDP (PPP). The country is a founding member of the European Union, the Eurozone, the OECD, the G7 and the G8. Italy is the eighth largest exporter in the world with \$514 billion exported in 2016. Its closest trade ties

are with the other countries of the European Union; with whom it conducts about 59% of its total trade.
