1. Trade between Sri Lanka & Maldives

Maldives is the 22nd export destination for Sri Lanka and accounted for 1 % of total exports from Sri Lanka in 2016. Total export value from Sri Lanka to Maldives was US\$ 95 Mn in 2016 and total imports from Maldives to Sri Lanka for the same period were US\$ 86 Mn. Sri Lanka's exports have increased from US\$ 59 Mn to US\$ 95 Mn with reference to the 2013 & 2016, indicating 61% growth.

Sri Lanka's main export products to Maldives in 2016 were Processed Food, Petroleum Products, Insulated Wires and Cables, Other Products of Base Metal and Other Vegetables. The main import products from Maldives were Fish, Petroleum oil, Vinegar, Meat, Parts of machinery, Cans (iron) and Spacecraft during the same year.

GEOGRAPHIC LOCATION

Maldives is a country of South Asia, situated in the Indian Ocean, south-southwest of India. It consists of approximately 1,190 coral islands grouped in a double chain of 26 atolls, spread

over roughly 90,000 square kilometers, making this one of the most disparate countries in the world.

ECONOMY

Maldives has an open economy, with a narrow export base but high dependence on imports for most of its economic activities. Consequently, foreign merchandise trade normally records a large deficit; imports have averaged around 61 percent of GDP in the last 5 years, while domestic exports, consisting primarily of fish and fish products have ranged between 11-15 percent of GDP. Services and transfers have shown a net surplus that has averaged around 34 percent of GDP in recent years, with service receipts being dominated by tourism and related activities.
