Sri Lanka's participation at Tyre Cologne 2024 from 4th to 6th June 2024 – Cologne, Germany

The Sri Lanka Export Development Board (EDB) in collaboration with the Sri Lanka Embassy in Germany is organizing Sri Lanka's participation at the Tyre Cologne 2024 Exhibition in Cologne Germany from 4th to 6th June 2024 to promote Sri Lankan Tyre Manufacturing sector.

The "Tyre Cologne" is an international trade exhibition for the tyre industry held in Germany biennially together with engaging conference sessions and special parallel events. Exhibitors from around the globe will present their innovations during the event including from tyres, to workshop supplies, tyre recycling and disposal. The event held in 2022 had attracted 300 exhibitors and more than 12,000 trade visitors from 100 countries. The "Tyre Cologne" will provide the right conceptual strategies for the international tyre industry and a platform to showcase future-oriented market developments.

OBJECTIVES

- To enhance the international visibility of Sri Lankan tyre industry and utilize the benefits of EU GSP+ concession of zero duty.
- To establish business contacts with the buyers of tyre related products across the world.
- To gain knowledge on market trends, new products, competitor intelligence, latest technology available, etc.

Tyres, wheels, inner tubes, carcasses, wheels (Rims), tyre & wheel accessories, vehicle accessories, workshop equipment, equipment & materials for tyre rethreading, repair materials and services for the tyre industry.

COST OF PARTICIPATION AND EDB ASSISTANCE

The participants have to meet the full cost of the participation including cost of stall, airfare, and accommodation, etc. and EDB may consider providing assistance towards the part cost of stall for SME companies.

The EDB will organize the B2B meetings for each participant company with the support of the Delegation of German Industry and Commerce in Sri Lanka (AHK) and the Sri Lanka Embassy in Germany during the exhibition.
