EDB FACILITATES CONTINUED SUPPORT FOR EXPORTERS DURING THE LATEST TRAVEL RESTRICTIONS

The Export Development Board (EDB) has made arrangements to facilitate export-oriented industries based on the circulars issued by the Health Authorities to continue operations during the lockdown of specific areas and inter-provincial travel restrictions subject to stringent health regulations.

Although travelling between provinces is restricted till 31 May, transport of cargo to/from the country's port of entry/exit is allowed during this period (proof required).

EDB said export-oriented industries are allowed to function within a bio-secure bubble by ensuring secure transport and accommodation for workers under the close supervision of the area medical officer of health, while agricultural activities are permitted normal operations with strong compliance to DREAM (Distance, Respiratory Etiquette, Aseptic technique, Mask).

The export enterprises in lockdown areas have also been given permission to function, however, employees residing in lockdown areas shall not report to work. The companies are advised to adhere to the relevant revised operational guidelines on preparedness and response for COVID-19 outbreak for the manufacturing/apparel industry and other health guidelines pertaining to the functionality of the enterprises issued by the Ministry of Health.

The EDB has taken steps to strengthen its helpdesk in order to assist exporters during this difficult time period by introducing 14 focal points for the relevant export product/service sectors, and their contact numbers are available on the EDB website.

All relevant Government authorities including the police and the tri-forces have pledged their continued support for the smooth operations of the export sector.

EDB PLANS REVISION TO 2021 EXPORT TARGET

The Export Development Board (EDB) is expected to revise the target for the year 2021.

EDB Chairman Suresh de Mel stated that the export target would certainly witness a revision due to the week-long travel restrictions that have come into effect and several areas being caught under isolation. However, he said it is too premature to assess the impact or divulge the revised target. He noted that the revision is ‘absolutely necessary.

Giving his focus on the garment industry, de Mel said the garment industry has been identified as very vulnerable to the situation. It is because the aforementioned industry was affected by Covid-19 immensely during Sri Lanka’s second wave of the pandemic.

“These are very uncertain times,” said the EDB Chairman, highlighting the unpredictability of the circumstances in the country which would subsequently affect the process of manufacturing and exporting.

“Maybe within a period of a week or two, we’ll be able to resume,” he added, referring to the period of the week after the travel restrictions, assuming that the Government-imposed health measures would decide the performance of the exports.

de Mel pointed out that the EDB doesn’t have information on this situation, adding that decision-making needs to be done with a prior, proper analysis because the collected data has the possibility of demonstrating the focal point of the arising situation.

According to EDB statistics, apparel exports contribute to the Sri Lankan economy higher than any other export merchandise while tea, rubber-based and coconut-based product exports remain at second, third and fourth places respectively.

Further, in comparison, apparel could only earn \$ 64.91 million during the month of April 2020, whereas, during April 2021 the mentioned sector is estimated to have reached an export earning of \$ 365.04 million which is a dynamic growth of 462.38 in percentage.

“It can also be the most uncertain period that we are going to face,” said de Mel emphasizing that the overall behavior can put all exports at a stake due to the new wave.

The apparel industry was drastically affected last year to the extent where a whole new Covid-19 cluster emerged leading to a deadly second wave in the country. It was with the diagnosis of a Covid-19 infected factory worker at an apparel plant in Minuwangoda on 3 October 2020.

EXPORT DEVELOPMENT BOARD SUPPORTS FARMERS & PROCESSORS TO OBTAIN SRI LANKA ORGANIC CERTIFICATION



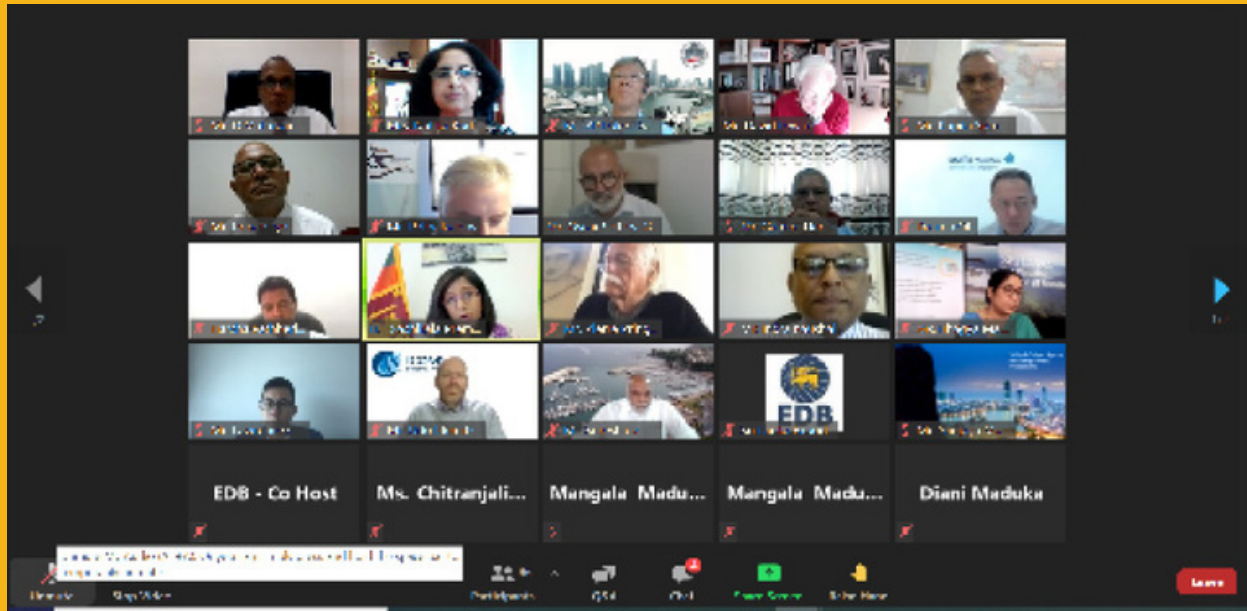
The Sri Lanka Export Development Board (EDB) is implementing an assistance scheme to enable farmers and processors in Sri Lanka to obtain organic certification as per the Sri Lanka Organic Standard – SLS 1324:2018. The certificates will be issued by the certification institutes accredited for SLS 1324:2018 by the Sri Lanka Accreditation Board (SLAB).

This assistance initiative intends to promote the National Organic Standard (SLS 1324:2018) among small farmers; streamline production, handling, processing, and labelling of organically grown agriculture products to meet a consistent standard; encourage conventional farmers to transform into organic cultivation and increase the production volumes and income; establish transparency throughout the supply /value chains from farm to market and upgrade farmers to obtain international certification in the future to meet the export demand.

The farmers and processors willing to follow organic agriculture and processing practices in rice, fruits, vegetables, cashew, herbs, fertilizer, pulses, spices, coconut kernel-based products, and green leaves are eligible to apply for assistance. The selected applicants will be assisted by the EDB to cover the initial cost of certification including field inspection and lab testing of samples.

ONLINE WORKSHOP ON DEVELOPMENT OF RECREATIONAL BOATING AND MARINA IN SRI LANKA



As an initiative of the Commercial section of the High Commission of Sri Lanka in Singapore, an online workshop on the Development of Recreational Boating Industry in Sri Lanka was successfully held on 11 May.

The event was co-hosted by the Sri Lanka Export Development Board and Singapore Boating Industry Association, and supported by Singapore-Sri Lanka Business Council and the Boat Building Technology Improvement Institute of Sri Lanka. Over 100 participants from Singapore and Sri Lanka participated at the event.

The online workshop comprised two panel discussions and a round table discussion. Panel sessions were focused on the development of the export sector of boat building and the development of the domestic sector particularly on marina development, infrastructure and nautical tourism with the participation of eminent industry experts from Sri Lanka, Singapore, UK, Spain, Thailand and Hong Kong. They represented mainly GMBA, UK, Thailand Yachting Business Association, Sub-committee of the Sri Lanka Singapore Business Council, Hong Kong Boating Industry Association, SUTL Enterprises – One 15 marina Singapore, GMBA, Spain and Sri Lanka Tourism Development Authority.

The two panel sessions were moderated by Colombo Dockyard Head of Marketing Prince Lye and Singapore Boating Industry Association Chairman Y.P. Loke respectively.

The workshop provided an opportunity for the state sector and private sector to the strategic direction of the industry and provide details of the capabilities and competitive position of the industry, the policy framework of marina development, and domestic opportunities for nautical tourism.

Presentations were made by the State Ministry of Boats and Ship Building, Sri Lanka Export Development Board, Boat Building Technology Improvement Institute, Neil Marine Ltd., Sail Lanka Charter Group to showcase Sri Lanka's supply capability and investment and JV opportunities in order to create awareness and to attract foreign investments, buyers and distributors.

High Commissioner Sashikala Premawardhane, Export Development Board Chairman Suresh de Mel and Singapore Boating Industry Association Chairman Y.P. Loke made opening remarks at the event.

The round table discussion held was chaired by the International Council of Marine Industry Association Secretary General Udo Kleinitz, with the participation of the Export Development Board, Board of Investment, Sri Lanka Tourism Development Authority, Boat Building and Technology Institute, Colombo Dockyard and Singapore Boating Industry Association and the session highlighted the key findings for way forward in both boat building industry and nautical tourism areas.

The online workshop facilitated an opportunity for stakeholders to understand the strategic direction of the recreational boating industry, market expansion, design and quality upgrading of the sector and gain an understanding of the domestic culture that needs to be developed in order for Sri Lanka to become an attractive marina destination in the region.

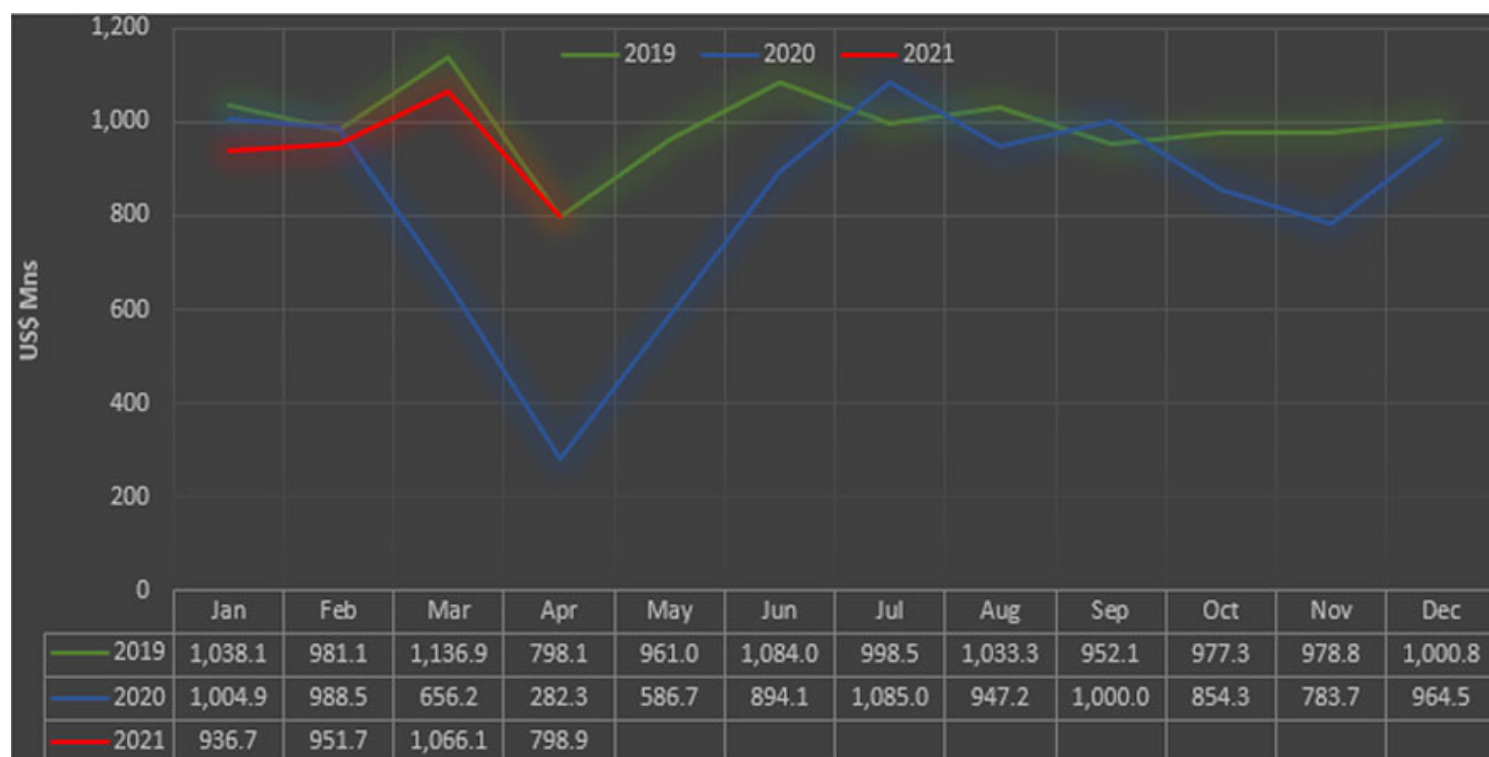
SRI LANKA'S EXPORT PERFORMANCE JANUARY - APRIL 2021

Sri Lanka's export performance continued its upward momentum in the first three months of 2021. Due to the Covid-19 pandemic-induced lockdown last year, exports were contracted by a record 64.63 percent in April 2020. However in April this year, exports grew up by 183 percent to US\$ 798.9 Mn in comparison to the previous year.

This growth could be attributed to the gradual lifting of Covid 19 restrictions imposed within the country and globally. It must be noted that the year-on-year growth in April 2021 was largely due to the negative growth a year ago.

The Export Development Board (EDB) Chairman Suresh de Mel said, "in comparison to the lowest point in April 2020, exports are up by 183% in April 2021. We thank the entire export community for serving the national economic needs at this vulnerable time. The EDB staff and I stand committed to help our exporters through this crisis in the best way possible".

Export Performance of Major Sectors

As shown in the table below, earnings from the export of major product sectors such as Apparel, Tea, Rubber-based Products, Coconut based, Spices, and Electrical & Electronic Components were increased both in the month of April 2021 and during the period of January to April 2021 compared to the previous year.

Export earnings from Spices and Essential Oils in April 2021, increased significantly compared to April 2020 - growth is mainly due to increased exports of cinnamon, pepper and cloves. The significant increase of 115.4 % recorded in the period of January to April 2021 compared to year 2020 - is an increase beyond the corresponding period of 2019 too.

Export earnings of tea increased y.o.y. in April 2021 by 1.14 % compared to April 2020. First four months comparison records at 19.79 % increase - The higher performance is due to demand growth of UAE, China and Libyan markets.

Earnings from all the major categories of Coconut based products increased by 100 % in April 2021 compared with April 2020 due to the improved performance in export of Coconut Oil, Liquid Coconut Milk, Cocopeat & Activated Carbon. Similarly, earnings from the export of all the major categories of Coconut based products increased by 51.99 % during the period of January to April 2021 compared to the corresponding period of 2020.

Export earnings from Rubber & Rubber finished products increased by 151.22 % y-o-y to US\$ 64.74 Mn in April 2021 due to the better performance of exports of Industrial & Surgical Gloves of Rubber (188.87%) and Pneumatic & Retreated Rubber Tyres & Tubes (172.72%). In parallel Export earnings from Rubber & Rubber finished products increased by 45.47 % during the period of January to April 2021 compared to the 2020.

Meanwhile earnings from export of Electrical and Electronic Components (EEC) increased by 186.05 % to US\$ 27.06 Mn in April 2021 in comparison to April 2020. Also, earnings from export of EEC increased by 41.21% to US\$ 129.09 Mn in the period of January to April 2021 compared to the corresponding period of 2020. Export of Insulated wires increased by 148.81 % in y-o-y to US\$ 4.18 Mn in April 2021 also increased by 34.04 % during the period of January to April 2021 to US\$ 22.17 Mn compared with the corresponding period of previous year.

Sri Lanka's Trade Performance in Major Markets

The single largest export destination of United States of America recorded US\$ 920.6 Mn worth of exports in the period of January to April 2021– a significant year on year increase of 21.2 % in comparison to US\$ 759.58 Mn recorded in 2020.

Exports to United Kingdom as the second largest trading partner recorded an increase of 16% to US\$ 294.23 Mn during the period of January to April 2021 compared with the corresponding period of previous year.

Further, Exports to China and Netherlands increased y-o-y by 77.79 % and 222.77% in April 2021 while the increase of the same markets improved by 64.89 % and 88.53 % respectively during the period of January to April 2021.

Strong performance made by Apparel and Liquid Coconut Milk exports has resulted to the increased Exports to Netherlands and better performance of export of Bulk tea, Mineral Sands, Activated Carbon and Cocopeat has resulted increased exports to China.

On a region wise comparison exports to all other regions increased except ASEAN during the period of January to April 2021 compared with the corresponding period of the previous year.
