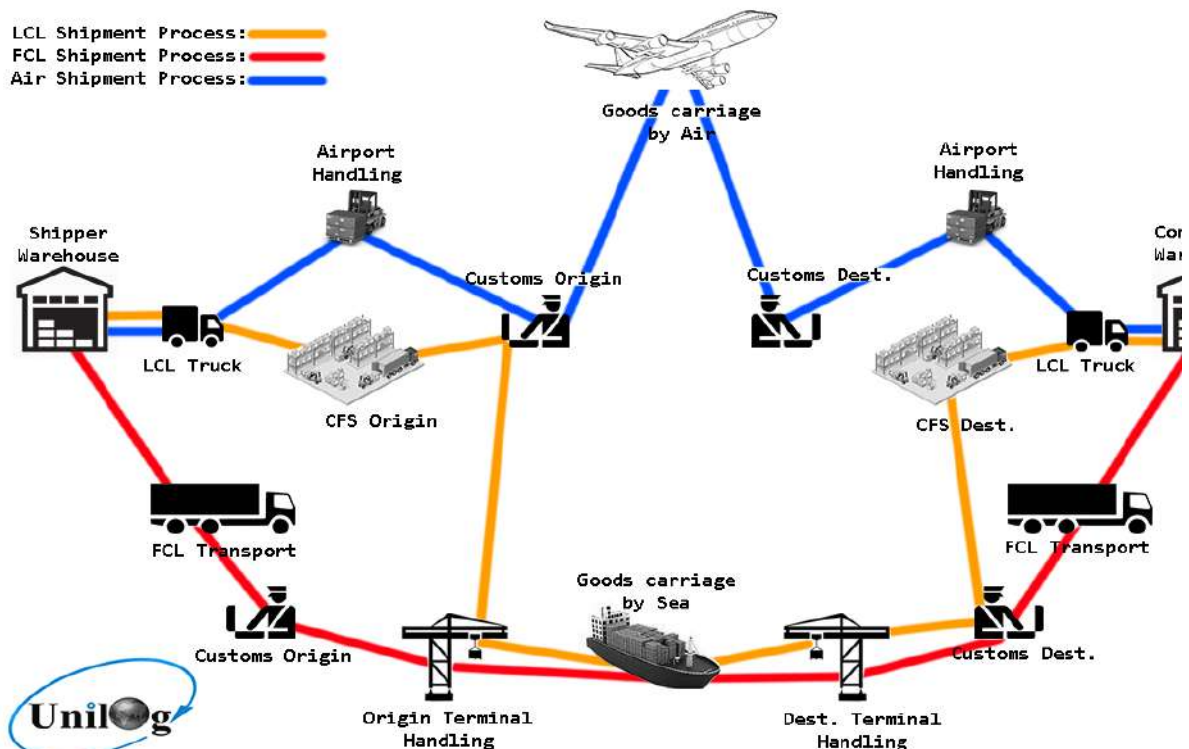

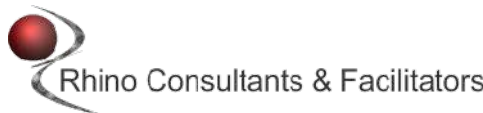

## Shipment Process



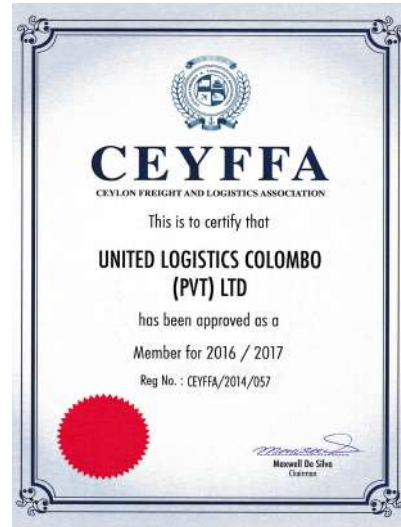
