1. Trade between Sri Lanka & Japan


Japan is the 8th largest export destination for Sri Lanka in 2019 by exporting 2.4% from the total exports. Sri Lanka Exports to Japan has been increased over the past few years and recorded USD 282 Mn in 2019. Japan was the Sri Lanka's 5th largest import destination in 2019 with the value of USD 876 Mn.

Sri Lanka's main export products to Japan in 2019 were Apparel, Boat Building, Tea, Coconut fiber products, Shrimps & Prawns, Animal Feed, Rubber Gloves and Tableware & Kitchenware etc. The main import products from Japan were Transport Equipment & Parts, Electrical & Electronic Products, Chemical Products, Plastic Products, Synthetic Rubber, Mineral Products, Woven Fabrics, and Base Metal etc.

6. Japan Generalized System of Preferences (GSP) Scheme

Japan grants preferential tariff treatment under its GSP (Generalized System of Preferences) scheme to 128 developing countries (including Sri Lanka) and 5 territories.

Under its GSP scheme, Japan applies reduced tariffs to designated import products originating from developing countries/territories, aiming to help them increase export income, advance industrialization and promote economic development. 337 agricultural & fishery products and 3,216 industrial products at HS nine-digit level were granted preferential tariffs. The GSP scheme excludes many agricultural products and certain industrial products.

GEOGRAPHICAL LOCATION

Japan is located in Eastern Asia, island chain between the North Pacific Ocean and the Sea of Japan, east of the Korean Peninsula

Total Area: 377,915 sq km

Climate: Varies from tropical in south to cool temperate in north

DEMOGRAPHY

Population: 125,507,472 (July 2020 est.)

Population growth rate: -0.27% (2020 est.)

ECONOMY

Scarce in critical natural resources, Japan has long been dependent on imported energy and raw materials. After the complete shutdown of Japan's nuclear reactors following the earthquake and tsunami disaster in 2011, Japan's industrial sector has become even more dependent than before on imported fossil fuels. However, ABE's government is seeking to restart nuclear power plants that meet strict new safety standards and is emphasizing nuclear energy's importance as a base-load electricity source.

Under the Abe Administration, Japan's government sought to open the country's economy to greater foreign competition and create new export opportunities for Japanese businesses, including by joining 11 trading partners in the Trans-Pacific Partnership (TPP). Japan also reached agreement with the European Union on an Economic Partnership Agreement in July 2017.
