Participating for the fair will be a good opportunity for Sri Lankan Companies to explore new market opportunities in Middle east region

The **International Apparel & Textile Fair (IATF)** is one of the **leading business-to-business (B2B) trade fairs** in the **Middle East & North Africa (MENA) region**, focused on the global apparel and textile industry. The fair attracts over 450 exhibitors from 20+ countries and **over 6000 buyers** from the UAE, Gulf Cooperation Council (GCC) states, Africa, Europe, and South Asia.
