TERMS OF REFERENCE (TOR)

ESTABLISHMENT OF INTERNAL CONTROL MECHANISM FOR CEYLON CINNAMON GI

1. BACKGROUND

Sri Lanka Export Development Board (EDB) is working with the Cinnamon Industry stakeholders in collaboration with the United Nations Industrial Development Organization (UNIDO) in the framework of the EU-Sri Lanka Trade Related Assistance to obtain Geographical Indication (GI) for "Ceylon Cinnamon" in the European Union (EU). EDB together with industry stakeholders has finalized "Ceylon Cinnamon GI Specification" document and submitted to the EU along with the GI application. The product characteristics and production methods mentioned in the specification document has to be assured & implemented by the members of the Ceylon Cinnamon GI Association (CCGIA) comprised of stakeholders of the Cinnamon value chain; nursery owners, growers, collectors, processors, traders, exporters to hold the ownership of "Ceylon Cinnamon GI" (CCGI).

The control mechanism for CCGIA is to be implemented in three levels as per the control plan which is attached in ANNEX 1

- a) Self-control by CCGIA members as per item mentioned in control plan annexed with TOR
- b) Internal control by CCGIA
- c) External control by Department of Export Agriculture.

The External control will be carried out by Department of Export Agriculture (DEA). The DEA is the public authority designated by Sri Lanka selected by CCGIA as an External Control body to apply GI at the EU and to verify overall compliance with the GI specifications & according to the EU Regulation No 1151/2012 of the European Parliament and of the Council of 21 November 2012. It is an executive authority established under the Export Agriculture Act No. 46 of 1992. The DEA monitors and provides assistance to cinnamon growers, including new plantings, productivity improvements and post-harvest measures, statistics and prices, as well as the organization and promotion of cultivation and processing.

Verification and control must take place regularly throughout the lifetime of a GI, not just once. Promoting and controlling the GI use is a continuous process. In short, a GI scheme must be managed continuously. The selected service provider who can push the CCGIA will be able to realize CCGIA's vision and EDB work plan activities and will report to and work under the supervision of the EDB.

It is expected to establish a digital traceability platform which will enable the country record the data of the members of the Ceylon Cinnamon value chain which eventually will be controlled and accepted to use the GI name. This digital system will also support the information and records of the quality and food safety of cinnamon products covered by the GI. This traceability system will also enable CCGI Internal and External controllers to capture relevant data to facilitate the adoption and sustained application of best and/or corrective practices in compliance with CCGI Specifications and CCGI Control Plan.

Export Development Board need to appoint an independent service provider or consultant who has competent to establish internal control mechanism among the value chain members In this regard, EDB is on the search for a service provider or consultant who can develop documentations, improve technical capacity, provide training for CCGIA members and implement Internal Control System as per the CCGI specifications and Control plan.

2. <u>EXPECTED OUTCOME</u>

Improve technical capacity of the CCGIA members and identified stakeholder groups in order to implement internal control system to obtain GI status for Ceylon Cinnamon.

3. PRE-QUALIFICATIONS/EXPERIENCE

The ideal service provider or consultant should possess minimum of 3 years in similar nature work during the recent past and having a proven track-record of mobilizing resources for systems development, providing evidence of successful client management skills and special emphasis on capacity development and training to better facilitate the certifying updated Food Safety and Quality certification schemes such as GLOBAL G.A.P, GAP, GMP, GHP, HAACP, Organic and ISO 22000 and knowledge on ISO/IEC 17065.

4. THE SCOPE OF CONSULTANCY

The service provider or consultant should quote for all the items that are indicated below in 4.1. The Export Development Board expects the service provider or consultant to complete requested items within six (6) months. Each item has to be quoted separately. A quoted item should fulfil all the requirements (otherwise the offer would not be considered). The requirements are indicated per unit; thus, the deliverables should be provided per unit.

- 4.1.2.2 Develop a Guidebook for self-controlled by CCGIA members as per Guidebook on Control Mechanism which is developed based on "Ceylon Cinnamon GI Specification" and CCGI Control Plan and obtain approval from EDB prior to issue CCGIA members
- 4.1.2.3 Design Training Programme for CCGIA Members with practical aspects/field aspects based on Guide on Book Control Mechanism and Guide Book for self-controlled by CCGIA and obtained prior approval for the content from the EDB
- 4.1.2.4 Design Training Programme on Control Mechanism for Personnel involved in control mechanism (Ex. CCGIA Executive Members, Relevant Managerial personnel and extension Officers of Department of Export Agriculture, Export Development Board) and obtain prior approval from the EDB.

- 4.1.3.2 Conduct two (02) Training Programmes for CCGIA Members based on EDB approved Guidebook on Control Mechanism and Guidebook for self-controlled by CCGIA members. The total number of participants shall not less than 100.
- 4.1.3.3 Conduct TOT Programme for Extension Officers (EO) of Department of Export Agriculture (DEA) with practical aspects/field activities to carry out External Control activities of CCGIA as per CCGIA Control Plan and to train new members of CCGIA and DEA EO on both guidebooks. The total number

of participants shall not less than 30. The service provider is expected to have capacity to deliver additional training, if requested by EDB for additional costs.

6 **REPORTING**

The selected service provider is expected to work directly with Director/Export Agriculture and staff of the Export Agriculture Division of EDB. The Service provider should communicate with other related EDB officers & Industry stakeholders, CCGIA and DEA as and when required. Communication with other Departments and institutions shall only be expected through EDB.

7 METHOD OF SELECTION

- 7.1. Insertion of advertisement in local newspapers/circulate the Bid Notice among either registered service providers or reputed firms/ individuals with the EDB calling for bids from suitable companies
- 7.2. A Pre- bid meeting will be conducted by the EDB in association with Technical Evaluation Committee (TEC)
- 7.3. The bidders to present their proposals to the EDB in order to evaluate the best proposal for selection.
- 7.4. The proposals to be evaluated by a Technical Evaluation Committee (TEC) appointed by the EDB and the TEC reserves the right to accept or reject bids. Final decision will be taken by the TEC. Reason for rejection of bids will formally be notified to rejected bidders
- 7.5. Obtain Departmental Procurement approval for the selected service provider

7.6. Once the acceptance of the Letter of Award by the bidder, bidder requires to enter into a legal agreement with the EDB.
