1. INTRODUCTION TO TRADE BETWEEN SRI LANKA & BRAZIL


Brazil is the 34th export destination for Sri Lanka. Total export value from Sri Lanka to Brazil was USD 65.79Mn in 2022 and total imports from Brazil to Sri Lanka for the same period were USD 42.66 Mn. Sri Lanka's exports to Brazil have increased by 9.98% in 2022 compared to the year 2021.

Sri Lanka's main export products to Brazil in 2022 were Gloves, of vulcanized rubber, Gloves with plastics/rubber, knit/crochet, New pneumatic tyres, of rubber, Desiccated coconuts, Cinnamon (incl. flowers), not crushed, not ground, Solid/cushion tyres, interchangeable tyre treads & tyre flaps, Preparations used in animal feeding, Brassieres, Parts of machinery, T-shirts & vests, knit/crochet.
