1. INTRODUCTION TO TRADE BETWEEN SRI LANKA & ITALY


Italy is the 5th export destination for Sri Lanka. Total export value from Sri Lanka to Italy was USD 640.18 Mn in 2022 and total imports from Italy to Sri Lanka for the same period were USD 293.36 Mn Sri Lanka's exports to Italy have increased by 10.06 % in 2022 compared to the year 2021.

Sri Lanka's main export products to Italy in 2022 were Apparel & Textile, Rubber & Rubber Based Products, Fish & Fisheries Products, Engineering Products, Coconut & Coconut based Products, Tobacco, Tea, Food, Feed & Beverages, Diamonds, Gems & Jewellery, Petroleum Products, Spices, Essential Oils & Oleoresins, Base Metal Products, Non-metallic Mineral Products, Fruits, Nuts and Vegetables, Other Manufactures etc.
