#### 1. INTRODUCTION TO TRADE BETWEEN SRI LANKA & POLAND

Poland is the 33<sup>rd</sup> export destination for Sri Lanka. Total export value from Sri Lanka to Poland was USD 61.96 Mn in 2023 and total imports from Poland to Sri Lanka for the same period were USD 24.05 Mn. Poland is the 44<sup>th</sup> import origin for Sri Lanka in 2023.


Sri Lanka's exports to Poland have decreased by 13.69% in 2023 when compared to the year 2022. Imports from Poland has decreased by 4.53% in 2023 when compared to the year 2022.

Sri Lanka's main export products to Poland in 2023 were Tea Packets, Gloves, Mitts & Mittens of Textile, Tea in Bulk, Pneumatic & Retreated Rubber Tyres & Tubes, Men's and Women's Under Garments, Bicycles Not Motorized, Unmanufactured Tobacco, Men's Outerwear, Manufactured Tobacco, Coco Peat, and Fiber Pith & Moulded products.

Sri Lanka's main imports products from Poland in 2023 were Other Paper & Paper Products, Tools, Implements, Cutlery & Parts, Cocoa and Cocoa Preparations, Animal Feed, Other Electrical & Electronic Products, Unmanufactured Tobacco, Inorganic Chemicals, Synthetic Rubber, Other Chemical Products, Other Manufactures.
