1. INTRODUCTION TO TRADE BETWEEN SRI LANKA & BRAZIL

Brazil is the 29th export destination for Sri Lanka. Total export value from Sri Lanka to Brazil was USD 84.70 Mn in 2024 and total imports from Brazil to Sri Lanka for the same period were USD 71 Mn. Brazil is the 32nd import origin for Sri Lanka in 2024.

Sri Lanka's exports to Brazil have increased by 16.03% in 2024 when compared to the year 2023. Imports from Brazil has increased by 52.89% in 2024 when compared to the year 2023.


Sri Lanka's main export products to Brazil in 2024 were Pneumatic & Retreated Rubber Tyres & Tubes, Industrial & Surgical Gloves of Rubber, Women's Outerwear, Gloves, Mitts & Mittens of Textile, Petroleum Oils, Men's and Women's Under Garments, Men's Outerwear, Other Electrical & Electronic Products, Activated Carbon, and T-shirts.

Sri Lanka's main imports products from Brazil in 2024 were Sugars, Sugar Confectionery & Bakery Products, Synthetic Rubber, Other Mineral Products, Pharmaceutical Products, Other Paper & Paper Products, Woven Fabrics, Starches, Glues, Enzymes, Unmanufactured Tobacco and Other Products of Base Metal.
